North Atlantic Energy Service Corporation (North Atlantic) provides in the enclosed a copy of the joint request by North Atlantic and FPL Energy Seabrook, LLC, dated May 20, 2002, to the U.S. Environmental Protection Agency (EPA), regarding the automatic transfer of the Seabrook Station NPDES Permit to FPL Energy Seabrook, LLC. As we have discussed, my client, FPL Energy Seabrook, LLC, will become the new majority owner and the operator of the Seabrook Station nuclear power plant in Seabrook, New Hampshire, in accordance with the Purchase and Sale Agreement for the Seabrook Nuclear Power Station dated April 13, 2002. Accordingly, Seabrook's current operator, North Atlantic Energy Service Corporation ("NAESCO"), and FPL Energy Seabrook, LLC, jointly submit this request for an automatic transfer pursuant to 40 CFR Section 122.61(b) of NPDES Permit Number NH0020338 from NAESCO to FPL Energy Seabrook, LLC, effective as of transfer of the facility on November 1, 2002 (if the date is revised, you will be notified promptly).

By their execution below, NAESCO and FPL Energy Seabrook, LLC agree that all permit responsibility, coverage, and liability shall transfer from NAESCO to FPL Energy Seabrook, LLC as of the transfer date stated above.
