

ENCLOSURE

- (1) How does UCLA's release level of net 40 cpm relate to the dpm/100 cm<sup>2</sup> values given in Regulatory Guide 1.86, "Termination of Operating Licenses for Nuclear Reactors?"
- (2) Were the survey instruments used by UCLA appropriate (i.e., of sufficient sensitivity) for detection of contamination and radiation fields to release material for unrestricted use?
- (3) It appears that non-removable contamination measurements were not performed for the reactor shielding blocks that were released for unrestricted use. Was the survey procedure and survey instruments used appropriate?
