The purpose of this modification is to exercise Option Year One of the contract, thereby extending the period of performance of the contract from October 1, 2002 to September 30, 2003, and increasing the contract ceiling and obligated amounts from \$62,050.00 to \$110,544.00. Accordingly, the contract is hereby modified:

1. Standard Form 1449, Block 26, TOTAL AWARD AMOUNT, is deleted and substituted with the following in lieu thereof:

"TOTAL AWARD AMOUNT \$110,544.00."

2. Section C.10, PERIOD OF PERFORMANCE, is deleted and substituted with the following in lieu thereof:

"The period of performance of this contract is from October 1, 2002 through September 30, 2003. The term of this contract may be extended at the option of the Government an additional three years."
