The purpose of this modification is to exercise the third option period under the subject contract in accordance with Paragraph C.7 - Option to Extend the Term of the Contract, which shall be billed in accordance with Paragraph B.16 - Schedule of Prices/Costs. As a result, the period of performance of the subject contract is extended from September 29, 2002 to September 20, 2003. In addition, the ceiling amount of the contract is increased by \$500,000 from \$1,490,303 to \$1,990,303.

Accordingly, the following changes are hereby made:

1. Under Paragraph B.16 - Schedule of Prices/Costs, Option Year 3 of the subject contract is hereby exercised.
2. Under Paragraph B. 18 - Consideration and Obligation, Subparagraph (a) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.18 CONSIDERATION AND OBLIGATION

- (a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$1,990,303."

3. Under Paragraph B.20 - Duration of Contract Period, the first sentence is hereby deleted in its entirety and substituted in lieu thereof the following:

"The ordering period for this contact shall commence on September 30, 1999 and will expire on September 29, 2003."
