SUMMARY OF FINDINGS

ER 05000282-02-301(DRS), 05000306-02-301(DRS), on 08/12-16/2002, Nuclear Management Company, LLC, Prairie Island Nuclear Generating Plant, Units 1 and 2.

The announced operator licensing initial examination was conducted by regional examiners in accordance with the guidance of NUREG-1021, "Operator Licensing Examination Standards for Power Reactors," Revision 8, Supplement 1.

Examination Summary

 Four reactor operator and four senior reactor operator applicants were administered written examinations and operating tests for initial operator licensing. All eight applicants passed all sections of their respective examinations resulting in the issuance of four reactor operator licenses and four senior reactor operator licenses (Section 4OA5.1).

4OA5 Other

.1 Initial Licensing Examinations

a. <u>Inspection Scope</u>

The NRC examiners conducted announced operator licensing initial examinations during the week of August 12, 2002. The NRC staff used the guidance established in NUREG-1021, "Operator Licensing Examination Standards for Power Reactors," Revision 8, Supplement 1, to prepare the examination outline and to develop the written examination and operating test. The NRC administered the written examination on August 16, 2002. The NRC examiners administered the operating test from August 12 through 15, 2002. Four reactor operator and four senior reactor operator applicants were examined.

b. Findings

Written Examination

The NRC developed the written examination. The licensee reviewed the written examination for technical accuracy from July 9 through 10, 2002, prior to the operating test validation week. Examination changes, agreed upon between the NRC and the licensee, were incorporated into the written examination in accordance with the guidelines provided in NUREG-1021.

The NRC examiners administered the written examination in accordance with NUREG-1021. The NRC examiners and licensee independently graded the written examination and concluded that all eight applicants passed. The licensee submitted no post written examination comments.

Operating Test

The NRC developed the operating test. The licensee reviewed the operating test for technical accuracy from July 15 through 18, 2002, during the operating test validation week. Examination changes, agreed upon between the NRC and the licensee, were incorporated into the operating test according to NUREG-1021. The licensee submitted no post examination comments on the operating test.

Examination Results

Four reactor operator and four senior reactor operator applicants were administered written examinations and operating tests for initial operator licensing. All eight applicants passed all sections of their respective examinations resulting in the issuance of four reactor operator licenses and four senior reactor operator licenses.

.2 Examination Security

a. <u>Inspection Scope</u>

The examiners reviewed and observed the licensee's implementation of examination security requirements during the examination preparation and administration.

b. Findings

The NRC examiners determined that the licensee's examination security practices associated with the development and administration of the operator license examinations were satisfactory.

The chief examiner presented the examination team's preliminary observations and findings to you and other members of the licensee management on August 16, 2002. The licensee acknowledged the observations and findings presented and did not identify any proprietary information.
