In your discussion with us, given that you had first-hand exposure to the fish return system, you suggested that the current screen mesh size does not appear to be a significant issue. We are in the latter stages of preparation of the final EIS; should you have an interest in providing additional insight on this issue, we request that such comments be received by the NRC no later than October 15, 2002, so that they may be considered in the final EIS.
