
In reference 1 and 2, NMC requested changes to Kewaunee Nuclear Power Plant (KNPP) Technical Specifications (TS). During subsequent discussions with the NRC, several enhancements and one typographical error were identified. The purpose of this letter is to submit the TS pages which include the improvement to the Proposed Amendment (PA). These changes do not affect the significant hazards consideration determination or the environmental evaluation of the referenced 1.

A001

The corrections are as follows:

1. Technical Specification 6.21.b is modified to remove the phrase "Licensees may make", because this is understood in the TS process.
2. Technical Specification 6.21.d is modified to correct an error where the TS refers to TS 6.5.b, which does not exist. TS 6.5.b was corrected to read TS 6.21.b.1 and TS 6.21.b.2.
3. The first sentence of TS 6.21.d was removed and made its own item, TS 6.21.c, for clarity.
4. Technical Specification 6.21.d is modified to change the requirement that TS Bases changes be provided to the NRC in accordance with 10 CFR 50.71(e). KNPP practice is to submit these changes as they are approved. This change will allow NMC to submit the Bases changes on this frequency not to exceed the frequency of 10 CFR 50.71(e).
5. TS 6.21.c and TS 6.21.d were renumbered to TS 6.21.d and TS 6.21.e respectively.

6.21 TECHNICAL SPECIFICATIONS (TS) BASES CONTROL PROGRAM

The Bases Control Program shall be established, implemented and maintained. This program provides a means for processing changes to the bases of these Technical Specifications

- a. Changes to the bases of the TS shall be made under appropriate administrative controls and reviews.
- b. Changes to bases may be made without prior NRC approval provided the changes do not require either of the following:
 - 1. A change in the TS incorporated in the license.
 - 2. A change to the USAR or bases that requires NRC approval pursuant to 10 CFR 50.59.
- c. Proposed changes that meet the criteria of 6.21.b.1 and 6.21.b.2 above shall be reviewed and approved by the NRC prior to implementation.
- d. The Bases Control Program shall contain provisions to ensure that the bases are maintained consistent with the USAR.
- e. Changes to the bases implemented without prior NRC approval shall be provided to the NRC on a frequency not to exceed that of 10 CFR 50.71(e).

6.21 TECHNICAL SPECIFICATIONS (TS) BASES CONTROL PROGRAM

The Bases Control Program shall be established, implemented and maintained. This program provides a means for processing changes to the bases of these Technical Specifications.

- a. Changes to the bases of the TS shall be made under appropriate administrative controls and reviews.
- b. Changes to bases may be made without prior NRC approval provided the changes do not require either of the following:
 1. A change in the TS incorporated in the license.
 2. A change to the USAR or bases that requires NRC approval pursuant to 10 CFR 50.59.
- c. Proposed changes that meet the criteria of 6.21.b.1 and 6.21.b.2 above shall be reviewed and approved by the NRC prior to implementation.
- d. The Bases Control Program shall contain provisions to ensure that the bases are maintained consistent with the USAR.
- e. Changes to the bases implemented without prior NRC approval shall be provided to the NRC on a frequency not to exceed that of 10 CFR 50.71(e).
