SUMMARY

By application dated April 30, 2002, General Atomics requested renewal of Certificate of Compliance No. 6347 for the Model No. FSV-3 package. General Atomics did not request any changes to the package design or authorized contents. The certificate has been renewed for a five year term.

EVALUATION

By application dated April 30, 2002, General Atomics requested renewal of Certificate of Compliance No. 6347 for the Model No. FSV-3 package. General Atomics did not request any changes to the package design or authorized contents. The staff reviewed the documents referenced in the certificate and determined that the required documentation was available and complete.

Condition No. 5(c) of the certificate was revised to clarify that the Transport Index for criticality control is the same as the Criticality Safety Index as defined in the International Atomic Energy Agency Regulations for the Safe Transport of Radioactive Materials (TS-R-1).

CONCLUSION

The certificate has been renewed for a five year term that expires on September 30, 2007. This change does not affect the ability of the package to meet the requirements of 10 CFR Part 71.
