Dear Ms. Beckman:

In accordance with Section G.5, Task Order Procedures, of the subject contract, this letter definitizes the subject task order modification which revises the key personnel, to include a Civil/Structural Specialist as required under Revision 2 of the Statement of Work, and increases the ceiling amount of this task order. The effort shall be performed in accordance with the revised Statement of Work included in Modification No. 1 of this task order.

As a result of this modification, the cost ceiling for the subject task order is hereby increased by \$37,847.03 from \$87,828.45, for a new cost ceiling of \$125,675.48. The amount of \$121,719.60 represents the estimated reimbursable costs, and the amount of \$3,955.88 represents the fixed fee.
