


The purpose of this modification is to:

- (1) revise subsection B.3 SCHEDULE OF PRICES/COSTS by increasing the staffing level, hours, and total price for a thirty (30) day contract extension period and two fifteen (15) day option periods;
- (2) revise subsection B.4 CONSIDERATION AND OBLIGATION --DELIVERY ORDERS by:
 - (a) increasing the total estimated amount of the contract (ceiling) associated with a thirty (30) day contract transition period, by \$8,887.20 from \$645,549.00 to \$654,436.20;
 - (b) providing incremental funding which increases the contract-obligated amount by \$8,887.20 from \$549,977.00 to \$558,864.20;
 - (c) adding the total estimated amount of the contract (ceiling) for optional transition period one, of \$4,570.56, associated with an increase in staffing to support the additional effort in accordance with contract optional transition period one support; and
 - (d) adding the total estimated amount of the contract (ceiling) for optional transition period two, of \$4,570.56, associated with an increase in staffing to support the additional effort in accordance with contract optional transition period two support; and
- (3) implement contract clause FAR 52.237-3 Continuity of Services by extending the contract period of performance to 8/06/02.

This modification confirms the Contracting Officer's e-mail message dated 7/2/02, providing FutureNet, Inc. authorization to continue with work associated with the Contract Number NRC-28-97-206 entitled "DATA ENTRY SERVICES FOR REGION I" in accordance with the SOW requirements listed in the contract and FutureNet, Inc.'s proposal, dated 7/01/2002 with revisions dated 7/02/2002. The amount of \$2,032 was authorized for expenditures until the contract modification was executed.

Accordingly, the following section of the contract is hereby modified:

"B.4, CONSIDERATION AND OBLIGATION -- DELIVERY ORDERS

1. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$654,436.20;
2. The amount presently obligated with respect to this contract is \$558,864.20;

(B) paragraph f and g are added as follows:

- f. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract for Optional transition period one is \$4,570 56;
 - g. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract for Optional transition period two is \$4,570.56."
3. Under Section I - CONTRACT CLAUSES, Subsection I.1 52.252-2 CONTRACT CLAUSES INCORPORATED BY REFERENCE (JUN 1988), contract clause FAR 52.237-3 CONTINUITY OF SERVICES (JAN 1991), the Contracting Officer hereby provides written notice to exercise the continuity of service clause and extends the contract period of performance to August 6, 2002. The following instructions are provided:
- "The Contractor shall--
- (1) Continue with work associated with this contract;
 - (2) when requested by the NRC PO, furnish phase-in training; and
 - (2) Exercise its best efforts and cooperation to effect an orderly and efficient transition to the successor."
