Emergency Plan Procedure Revisions


On August 30, 2002, Peach Bottom Atomic Power Station, Units 2 and 3, and Limerick Generating Station, Units 1 and 2, were incorporated into the Exelon Generation Company Standard Emergency Plan. As a result, various emergency procedures involving Peach Bottom and Limerick have been deleted or superseded.

Enclosed are revised Emergency Plan Procedures for Peach Bottom Atomic Power Station (PBAPS), Units 2 and 3, and Limerick Generating Station (LGS), Units 1 and 2. These procedures are required to be submitted within thirty (30) days of their revision in accordance with 10CFR50, Appendix E, and 10CFR50.4.

In order to facilitate updating of NRC copies of the Peach Bottom and Limerick Emergency Plan Procedures, we have enclosed a matrix that identifies which procedures have been deleted or superseded.
