Describe Follow-up: (Telephone, Internet, Chamber of Commerce, Other) First followed up with NRC licensee 11-27073-01, The Amalgamated Sugar Company, located in Paul, Idaho. Radiation Safety Officer Chris Pound reviewed his current and past inventories to see if the gauge was ever transferred to the Paul facility. He found no evidence that the device was ever transferred to the facility in Paul. He said that at some point in time, Amalgamated had a research facility in Filer. He lives near Filer and physically went to the Amalgamated location there. Currently, Amalgamated only has a beet pile (factory storage overflow) in Filer, and no research facility. He spoke to Leonard Cerb ((208) 733-4104), the Agricultural Manager for the Filer area. Cerb confirmed that there was an Amalgamated research facility in Filer in the late 70s, early 80s time frame. He also indicated that the site of the former Filer facility was deeded to the City of Filer. Pound indicated that the Amalgamated facility in Twin Falls was physically closer to Filer than Paul. Checked with the Twin Falls facility, Larry Lloyd, Facility Manager. He said that Twin Falls was not in possession of any gauges at all. Lloyd went through some archived material and stated that records indicate that the gauge in Filer left their site in 1982 and was sent to Nuclear Sources & Services (NSSI).

Contacted Martha Hernandez @ ThermoMeasureTech. She was unable to produce any information about the gauge sent to Filer.
