SUBJECT: GE NUCLEAR ENERGY REQUEST FOR WITHHOLDING INFORMATION  
FROM PUBLIC DISCLOSURE

Dear Mr. Stramback:

By letter and affidavit dated September 4, 2002, you submitted draft presentation slides entitled, "GE BWR Constant Pressure Power Uprate Program - Fuel Transition Considerations and SE Open Items," and requested that they be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.790. These slides in a revised form were used at a meeting with the NRC staff held on September 10, 2002.

A nonproprietary copy of this document was not provided for placement in the Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by General Electric's competitors without license from General Electric constitutes a competitive economic advantage over other companies;
- b. Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product;

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.790 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the draft and final presentation slides entitled, "GE BWR Constant Pressure Power Uprate Program - Fuel Transition Considerations and SE Open Items," marked as proprietary, will be withheld from public disclosure pursuant to 10 CFR 2.790(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
