
As discussed this afternoon, we are submitting a clarification report in accordance with NRC Form 241. Our work on the Troupe Warehousing project in Erie, PA is complete.

We used a Troxler Model 3430 moisture-density gauge to check fill compaction a total of 15 days during the period of 05/08/02 through 09/01/02. Our initial application for this project was for 117 days, so a delete of 102 days is in order. The project did not work out to be as big as we had expected. Please delete all days except the following: 5/8, 9, 21, 23 & 29; 6/14, 17, 19, 21 & 25; 7/10; and 8/7, 8, 13 & 27 (15 total days).

This should leave a total of 165 days (180 - 15 used = 165) of possible use for the remainder of calendar year 2002. At the present time we do not have any projects that require the use of our nuclear gauges. Thanks for your assistance. Please contact me at (716) 685-2821 if you have questions.


