Millstone Nuclear Power Station, Unit Nos. 1, 2, and 3
Request to Amend 10CFR71 Quality Assurance Program

By letter dated August 8, 1991,⁽¹⁾ Northeast Nuclear Energy Company (NNECO) requested an amendment to its Quality Assurance Program Approval No. 0207 to delete authority to engage in design or fabrication activities of shipping packages for radioactive material.

On August 20, 1991,⁽²⁾ the NRC issued Revision No. 4 to Quality Assurance (QA) Program Approval No. 0207 which limited NNECO's activities to that of procurement, maintenance, repair, and use. Prior to issuance of Revision No. 4, NNECO was classified as a user and fabricator.

Subsequent to the issuance of Revision No. 4, NNECO has determined that it is necessary to amend its QA Program for radioactive material packages to allow authority for the design and fabrication of shipping packages. The reason for this amendment request is to allow shipment of the Millstone Unit No. 2 steam generators to Barnwell, South Carolina, which are being removed and disposed of in 1992.

NNECO hereby requests that QA Program Approval No. 0207 be amended to provide authority for design and fabrication of packages for the transportation of licensed material. In accordance with the schedule of fees in 10CFR170.31, enclosed herewith is the amendment fee of \$230.


