Consequently, the Permanent Plant Modification and Changes, Tests, and Experiments inspection scheduled for November 4-8, 2002 will not be performed. This inspection will be conducted along with the Safety System Design and Performance Capability Inspection scheduled for August 11-30, 2003.
