Dear Dr. Khatib-Rahbar:

The purpose of this modification is to extend the expiration date of the subject task order from "September 18, 2002" through "March 18, 2003," at no additional cost or obligation to the Government. The extension is necessary to allow the U.S. Nuclear Regulatory Commission (NRC) adequate time to review draft ERI report ERI/NRC 02-201, and provide comments to the contractor to be addressed and subsequently incorporated in the final report. Accordingly, the task order is hereby revised as follows:

The second paragraph of the basic task order is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"Task Order No. 3 shall be in effect from May 22, 2000 through March 18, 2003."

The issuance of this modification does not amend any other terms or conditions of the subject task order; including the ceiling amount of \$80,633.07.
