

The purpose of this modification is to provide incremental funding in the amount of \$225,000.00 under the contract for the payment of utility services (\$220,000) and reimbursable services (\$5,000). The obligated amount for utility services is increased from \$5,364,107 by \$220,000.00 to \$5,584,107. The obligated amount for reimbursable services is increased from \$453,833 by \$5,000 to \$458,833. Accordingly, the contract is modified as follows:

Paragraphs B and E under Section B.5 TOTAL ESTIMATED COST FOR UTILITIES AND REIMBURSABLE SERVICES is modified to read as follows:

- B. Total funds in the amount of \$5,584,107 have been obligated for the payment of utility services for the base and option periods.
- E. Total funds in the amount of \$458,833 have been obligated for the performance of reimbursable work for the base and three option periods.

Paragraph D under Section B.6 CONSIDERATION AND OBLIGATION - FIRM FIXED PRICE is hereby modified to read as follows:

- D. The total ceiling amount for the Firm Fixed Price services, reimbursable contract services, and payment of utilities for Option Year 3 is \$2,275,640.

This modification obligates FY02 funds in the amount of \$225,000.00.
