Attached for your signature is a Federal Register notice that amends several parts in 10 CFR Chapter I. These amendments are necessary to reflect the current address of the NRC Public Document Room and to correct the information collection sections in the Code of Federal Regulations. These amendments also reflect other minor administrative changes. This action is necessary to inform the public of the administrative changes to the NRC's regulations.

Because these amendments deal with agency organization and procedures, the notice and comment provisions of the Administrative Procedures Act do not apply pursuant to 5 U.S.C. 553 (b) (A). Therefore, good cause exists to dispense with the usual 30-day delay in the effective date because the amendments are of a minor and administrative nature.
