Pam,

I am submitting an OCP for a proposed rulemaking that covers changes to three 10 CFR Parts:

10 CFR 30 (3150-0017)  
10 CFR 40 (3150-0020)  
10 CFR 70 (3150-0009)

Tremaine Donnell submitted a clearance renewal for Part 30 (3150-0017) yesterday. We would like you to enter the attached rule OCP for Part 30 into OMB's system for processing before the clearance renewal sent to you yesterday.

You already have a clearance renewal in your system for Part 40 (3150-0020). This is merely a reminder that the attached OCP will need to be entered for Part 40 as soon the Part 40 renewal package is approved.

You should be able to enter the Part 70 OCP as there are currently no clearances at OMB affecting Part 70 (3150-0009).

NRC prepares one OCP for all amendments to rules, regardless of the number of clearances affected. When we submitted paper copies, this meant that we submitted 3 copies of the same OCP for each OMB 83-I submitted. In this case, that would have meant 9 copies of the same OCP. Since we are sending this electronically, I am only submitting one copy of the OCP. Please let me know if you have a problem with this. I have attached the rule supporting statement, FRN, and proposed rule. I will fax you the 3 OMB 83-I's for the rulemaking.
