MEMORANDUM AND ORDER

According to the most recent quarterly status report submitted in this proceeding by Licensee Department of the Army on October 1, 2002, the NRC Staff is expected to complete this month its administrative/preliminary technical review of the Army's revised decommissioning plan and environmental report. As the status report further recites, those documents had been supplied to the Staff in June 2002 and certain additional information requested by the Staff on September 9 was furnished to it on September 20.

To await further administrative developments, this proceeding has now been held in abeyance by me for almost a year at the behest of the hearing requestor, Save the Valley. For that reason, I wish now to obtain from the Staff either (1) confirmation that its pending review in fact will be completed by October 31, 2002, and the results then made available to those

concerned; or (2) the best current estimate as to when the review will be completed, with an explanation as to the cause for the further delay. A memorandum containing the requested information should be filed and served on the parties on or before Thursday, October 17, 2002.

It is so ORDERED.
