The purpose of this modification is to: (1) extend the expiration date of the contract by three (3) months, from "September 30, 2002" to "December 31, 2002", to allow the contractor to continue to ONLY provide Debt Collection service. No additional task orders will be awarded under this contract.; (2) increase the ceiling and obligated amounts for Debt Collection services by \$8,580 00 from \$67,330 00 to \$75,910 00, and (3) increase the total contract award amount by \$8,580 00 from \$5,577,835.00 to \$5,586,415.00. Accordingly, the contract is hereby modified as follows:

1. Under subsection A.1, Item No. 7, Debt Collection, item c , ADD 220 hours to the "Staff" labor category at the fixed hourly rate stipulated in the contract. Therefore, item No. 7 is DELETED in its entirety and SUBSTITUTED with the following in lieu thereof:

3. On page 2 of SF 1449, Block No. 26, the total contract award amount is DELETED and REPLACED with "\$5,586,415 00".
