The purpose of this modification is to increase the contract ceiling amount by \$445,000.00, from \$1,602,000.00 to \$2,047,000.00 and provide incremental funding in the amount of \$400,000.00, thereby, increasing the obligated amount from \$1,600,000.00 to \$2,000,000.00. Accordingly, the contract is modified as follows:

1. Section B.3, SCHEDULE OF ITEMS AND PRICES is deleted entirely and replaced with the following:

**B.3 SCHEDULE OF ITEMS AND PRICES**

Upon receipt of a delivery order from the NRC Project Officer, or designee, the Contractor shall provide Potassium Iodide (KI) Tablets in accordance with the Statement of Work, at the price stated below. The FIRM FIXED PRICE PER TABLET RATE INCLUDES ALL DIRECT AND ALL INDIRECT COSTS to perform the work specified in the Statement of Work.

2. Under Section B.3.1, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS the first sentence of Paragraphs "(a)" and "(b)" is deleted entirely and replaced with the following:

- (a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$2,047,000.00
- (b) The amount presently obligated with respect to this contract is \$2,000,000.00.

As a result of this modification, the contract ceiling amount is increased by \$445,000.00, from \$1,602,000.00 to \$2,047,000.00. All other terms and conditions of this contract remain the same.
