In accordance with 10 CFR 71.101(f), we are hereby notifying you of Arizona Public Service Company's intent to use the previously approved PVNGS Quality Assurance (QA) Program with regard to radioactive transport packages. The PVNGS QA Program complies with 10 CFR 50 Appendix B and is described in Section 17.2 of the PVNGS Final Safety Analysis Report previously submitted to the NRC on October 1, 1979, and as amended through Amendment 14, on docket number STN-50-528, 529, and 530. The NRC staff has approved the PVNGS QA Program as stated in the Safety Evaluation Report related to the operation of PVNGS Units 1, 2 and 3 dated November, 1981 and as supplemented through Supplement 9.

Also in accordance with 10 CFR 71.12(c)(3), Arizona Public Service is hereby notifying you of its intent to use the following NRC approved transportation casks to transport licensed material under the PVNGS Units 1 and 2 operating licenses NPF-41 and NPF-46 respectively.
