The governing body prevails upon the New Jersey Environmental Protection Agency to consider stricter regulations for scheduled maintenance at nuclear plants and to hold Oyster Creek Generating Station and its parent company, Exelon Nuclear, liable for violating allowable temperatures and performing maintenance at a time when such maintenance is prohibited.
- 3. That a certified copy of this resolution be forwarded to the Exelon Nuclear, Oyster Creek Generating Station, the Nuclear Regulatory Commission and the New Jersey Department of Environmental Protection, 9th District and Lacey Township Committee.


