SUBJECT: SUMMARY OF THE AUGUST 1, 2002, MEETING BETWEEN THE
NUCLEAR REGULATORY COMMISSION STAFF AND
TRANSNUCLEAR, INC.

On August 1, 2002, management and staff from the Spent Fuel Project Office (SFPO) met with representatives from Transnuclear, Inc. (TN) to discuss a proposed response to the Request for Additional Information (RAI) issued July 3, 2002, on Amendment 5 to Certificate of Compliance (CoC) No. 1004. Amendment 5 adds the NUHOMS-32PT canister to the Standardized NUHOMS Modular Storage System. RAI No. 2 focused entirely on the outstanding thermal issues with the review. The meeting was divided into a non-proprietary segment and a proprietary segment. Attachment 1 is an attendance list. This meeting was noticed on July 19, 2002.

During the meeting TN outlined their proposed response to RAI No. 2 questions. Attachment 2 contains a copy of the slides presented by TN during the non-proprietary portion of the meeting.
