**SUBJECT: Amendment request SS&D and Exempt License concerning MP5 and M203 Grenade Launcher Day/Night Sight Module.**

**SUMMARY:**

The objective of the conference call was to inform 21<sup>st</sup>. Century regarding the outcome of NRC review of their license amendment application dated October 14, 2002 and NRC's proposal to issue an amendment to their exempt license allowing limited authorization to meet immediate needs of the US Military.

NRC informed 21<sup>st</sup>. Century that their request, to amend registration certificate No. NR-0365-D101-E, to include the Ghosting gun sights series cannot be honored at this time as 21<sup>st</sup>. Century has not provided full information that provides complete assurance that the product meets the regulatory requirements and can be authorized for wide spread distribution.

Based on the information provided by the applicant, significant amount of historical performance of similar devices and risk assessment NRC is to issue a conditional license. This limited conditional license amendment will authorize, during the period November 13, 2002, through January 31, 2003, to distribute Models DNS390 and DNS200 Insight Technology Ghosting sights on Models MP5 and M203 grenade launchers, as described in letter October 14, 2002, and facsimile dated November 8, 2002, for use by the United States military.

21<sup>st</sup>. Century agreed to the NRC proposal and made a firm commitment to work with NRC to provide all requested information to assure products complete compliance with 10 CFR 32.22, by January 01, 2003.

**ACTIONS**

NRC will issue limited conditional license to allow the distribution of Models DNS390 and DNS200 Insight Technology Ghosting sights on Models MP5 and M203 grenade launchers for use by the US Military.

21<sup>st</sup>. Century indicated they intend to hire consultants and asked the NRC staff for recommendations.. NRC provided to 21<sup>st</sup>. Century the Health Physics Society telephone and Internet web sight address which may assist them in locating consultants.

NRC will provide 21<sup>st</sup> Century directions as to how to log on to NRC" ADAMS" to gain access to publically available information including NRC issued licences.
