Dear Ms. Carr:

As you are aware, B&W Naval Nuclear Fuel Division has received High Enriched Uranium (HEU) purchased by the U.S. Government from Kazakhstan in the former Soviet Union. The purchase agreement stipulated that the HEU would be subject to international safeguards as administered by the International Atomic Energy Agency (IAEA).

In accordance with the U.S./IAEA Safeguards Agreement, we anticipate that the IAEA will apply safeguards to the HEU at B&W to which it is entitled for verification purposes under 10 CFR Part 75.13. However, since some information concerning quantities of HEU are likely to be classified CONFIDENTIAL National Security Information (NSI), we expect that IAEA inspectors will require access to classified material control and accounting information as well as information related to the location of the HEU.

Therefore, pursuant to 10 CFR Part 95.36, Enclosure 1 is the Disclosure Authorization for the release of NSI to IAEA inspectors identified in Enclosure 2.

In order that arrangements can be made to facilitate compliance with 10 CFR Part 75, the NRC Division of Security should be notified immediately if you believe that IAEA's visit requires access to NSI above the CONFIDENTIAL level.

The IAEA representatives will present credentials as specified in 10 CFR Part 75.7 to confirm their identity. Please notify Region II if any individual not identified in Enclosure 2 attempts to gain access to NSI.

DISCLOSURE AUTHORIZATION

In accordance with 10 CFR Part 95.36, the NRC Division of Security hereby authorizes B&W to disclose CONFIDENTIAL National Security Information (CNSI) in connection with verification visits and inspections pursuant to 10 CFR Part 75.13 and 75.42. Restricted Data may not be disclosed to IAEA inspectors. The disclosure of CNSI must:

Be identified for release under the Reporting Identification Symbol XUY.

Be marked specifically for release to IAEA.

Additionally, B&W is required to:

Maintain records regarding IAEA visits and inspections for five years beyond the date of the visit or inspection. Such records shall specifically identify each document that was released and its date.


Identify the categories of documents that were released to an IAEA representative and the date of the release.

Maintain the NRC Division of Security disclosure authorization for five years beyond the date of the visit or inspection.

Take the necessary measures to preclude access to NSI by participants of other international agreements unless provided for under the terms of a specific agreement.

This disclosure authorization expires upon completion of tasks stipulated in the agreement between Kazakhstan and the U.S. Government.
