1 The Court, having considered the Motion of Pacific Gas and Electric Company
2 ("PG&E") For Order Authorizing Debtor To Pay Refunds To Customers For Pre-Petition
3 Electric Tariff Rule 20-B Pole Removal Costs (the "Motion"), the Memorandum Of Points
4 And Authorities In Support Of Debtor's Motion, and the Declaration of Rocco Colicchia in
5 support thereof, any opposition to the Motion, the record in this case, and any admissible
6 evidence and argument presented to the Court, hereby finds as follows:
