**SUMMARY:** The Unit began the month at ~75% reactor power, with a reactor core coast down in progress. On 10/04/2002, at 2119 hours, a power reduction was commenced in preparation for a refueling outage. At 2215 hours that same day, the Unit automatically tripped off line from 42% reactor power while performing pre-outage testing of the Main turbine oil trip system. The 1R17 refueling outage commenced at this time.
