SUBJECT:		ALUATION OF SITES IDENTIFI SEPTEMBER 6, 2000	IED IN THE USA TODAY

On October 2, 2000, the staff provided the Commission a list and an analysis of the sites from the USA Today article. The staff also responded to several questions from Commissioner Merrifield's office, and its reply was sent to the Commission TAs. At that time, the staff was resolving the status of the last few sites on the USA Today list, and its review was not final. The staff has now completed its review of the sites and is providing the attached the list and final summary of the 153 sites.

The staff is continuing its review of the approximately-577 sites listed on the "FUSRAP List" document (of sites considered for inclusion in the FUSRAP program) that DOE posted on its website. The sites in the USA Today list were almost all included on the DOE "FUSRAP List." In its review, the staff is coordinating with DOE and EPA to obtain any information that they have on the sites, as well as checking NRC records. The staff is concentrating on the sites on the "FUSRAP List" where DOE has identified NRC as the cognizant authority. The staff will provide information on its review of DOE's "FUSRAP List" once its analysis is complete.

## **USA Today Review Summary**

DWM staff has reviewed the sites listed in the 9/6/00 USA Today article on toxic exposure to workers. The list was examined to determine if the sites are included within the formerly licensed sites identified by ORNL, Listed as FUSRAP, an Active license Under NRC/Agreement States or other agencies such as EPA, DOE or UMTRAP. The following is the result:

- 36 out of 153 are listed as NRC cognizant (at least in part) in the DOE report (24%).
  - 3 out of 36 sites are active NRC licensees:
    - Mallinckrodt Chemical St. Louis, MO (complex decommissioning a.
    - U.S. Pipe and Foundry Burlington, NJ b.
  - c. General Atomics La Jolla (San Diego) CA
    3 out of 36 are currently terminated NRC licenses undergoing cleanup: 2.
    - Horizons, INC. Cleveland, OH SDMP site transferred to the state on 8/99 estimated completion in 2000.
    - Nuclear Materials Concord, MA-SDMP site transferred to the b. state on 3/97 active decommissioning
    - Westinghouse Electric Bloomfield, NJ completed C. decommissioning but waiting for NRC to perform confirmatory
  - 2. The remaining 30 of these have terminated (expired, retired or transferred to state) licenses.
- 26 out of 153 sites are under FUSRAP. One of these is also an NRC active site B. under decommissioning (Mallinckrodt Chemical). An additional 3 out of 153 were under consideration for FUSRAP classification. This accounts for an additional 28 sites. (18%)
- 77 of the 153 sites are listed by DOE as eliminated from consideration (i.e. sites C. reviewed by DOE, but not FUSRAP or NRC). One of these is still under active NRC license (U.S. Pipe and Foundary), accounting for an additional 76 sites. (50%)
- 10 out of 153 has been identified by DOE as DOE, or EPA cognizant (7%). D.
- 2 sites appear to not have possessed radioactive materials (1%): E.
  - Phelps-Dodge Copper in Bayway, NJ (per DOE) 1.
  - Raytheon in Allston, MA (per DOE and USA Today) 2.

DWM staff has met with OPA and discussed these efforts as well as familiarized OPA with our decommissioning approach as discussed in SECY-0094.
