We have reviewed the final regulations in Wisconsin Administrative Code, Chapter HFS 157 entitled, "Radiation Protection," which became effective on August 1, 2002. The regulations were reviewed by comparison to the equivalent NRC regulations. We discussed our review of the regulations with you and with Ms. Cheryl Rogers on September 17, 2002.
