SUBJECT: CABOT CORPORATION MEETING SUMMARY

On November 20, 2002, the U.S. Nuclear Regulatory Commission (NRC) staff met with representatives of Cabot Performance Materials (CPM, a subsidiary of Cabot Corporation, the licensee) and its consultants at Cabot's Boyertown, Pennsylvania facility. CPM requested renewal of source material license SMB-920 on April 3, 2002, and the meeting was primarily to discuss the information lacking in CPM's October 10, 2002, response to the June request for additional information (RAI). The meeting was an announced open meeting, with attendance by Cabot Corporation, Cabot contractors, representatives from the Pennsylvania Department of Environmental Protection (PADEP), and NRC staff from Headquarters and Region I offices. A list of attendees is provided in Attachment 1 and the agenda for the meeting is provided as Attachment 2. No members of the public attended this meeting.

CPM staff conducted a guided site tour of the portions of the facility that handle and manage uranium and thorium as source material. This included the ore receiving and grinding operation, the acid digestion and ion exchange process area, the bulk storage buildings where the spent ore residue (filter cake) is stored, and the wastewater treatment and neutralization operations. In addition, groundwater monitoring locations and the surface water discharge outfall location were observed.
