

The purpose of this modification is to provide incremental funding in the amount of \$26,000.00, thereby increasing the obligated amount in the contract from \$556,000.00 to \$582,000.00. Accordingly, the contract is hereby modified as follows:

Section B, Subsection B.2 entitled "CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988) ALTERNATE 1 (JUN 1991)," paragraphs (c) and (d) are deleted in their entirety and substituted with the following in lieu thereof:

"(c) The amount currently obligated by the Government with respect to this contract is \$582,000.00, of which the sum of \$ 538,350.00 represents the estimated reimbursable costs, and of which \$43,650.00 represents the fixed fee

(d) It is estimated that the amount currently obligated will cover performance through December 31, 2002."

A summary of obligations for this contract from the date of award through the date of this action is provided as follows

This modification obligates FY03 funds in the amount of \$26,000.00.

All other terms and conditions of the subject contract, including the ceiling amount of \$796,886.00, remain unchanged.
