The purpose of this modification is to exercise the four month optional requirement, which will extend the subject contract from November 30, 2002 to March 31, 2003, to allow for continuation of maintenance services for the Hewlett-Packard and PC-based version of the Bibliographic Retrieval System (BRS), whereby costs billed by the contractor will be paid by the Government at the rates currently reflected under the contract. As a result of extending this effort, the ceiling amount of this contract is increased by \$20,000.00 from \$535,306.24 to \$555,306.24 and the obligated amount is increased by \$16,000.00 from \$535,306.00 to \$551,306.00.

The contractor waives receipt of the preliminary notice as reflected in its letter to the NRC dated November 25, 2002, which is attached hereto and made a part hereof this contract modification.

Accordingly, the following changes are hereby made:

1. Under Section B - SUPPLIES OR SERVICES AND PRICES/COSTS, Paragraph B.4 - CONSIDERATION AND OBLIGATION, Subparagraph (a) and (b) are hereby deleted in their entirety and substituted in lieu thereof the following:

"B.4 CONSIDERATION AND OBLIGATION

- (a) The total estimated cost to the Government for full performance of work under this contract is \$555,306.24.
- (b) The amount presently obligated by the Government with respect to this contract is \$551,306.00."

2. Under Section F - DELIVERIES OR PERFORMANCE, Paragraph F.4 - DURATION OF CONTRACT PERIOD, is hereby deleted in its entirety and substituted in lieu thereof the following:

"F.4 DURATION OF CONTRACT PERIOD

The ordering period for this contract shall commence on January 1, 1997 and will expire on March 31, 2003."
