

The purpose of this modification is to obligate FY 2003 incremental funding in the amount of \$5,409.60, thereby increasing the obligated amount of this contract from \$1,002,000.00 to \$1,007,409.60. Accordingly, the contract is modified as follows:

Section B.1.4, "CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUNE 1988)," the first sentence in paragraph "(b)" is revised to read as follows:

"(b) The amount presently obligated with respect to this contract is \$1,007,409.60."
