**JOINT STIPULATION REGARDING  
SUBMISSION OF SUPPLEMENTAL APPENDIX**

Petitioners State of Nevada, Clark County, Nevada, and the City of Las Vegas, Nevada (collectively, "Petitioners") and Respondents United States Nuclear Regulatory Commission and the United States (collectively, the "NRC") hereby jointly stipulate and agree to the following:

1. The NRC has compiled and certified an administrative record for consideration by this Court in this matter.
2. Petitioners have compiled a list of documents that they believe the NRC did or should have considered during its deliberations underlying this action. Petitioners have requested that the NRC add said documents to the certified administrative record.
3. The NRC has agreed to the inclusion of several of these documents in the administrative record and will file a supplemental index identifying those documents it has agreed to add to the certified administrative record. The NRC has otherwise declined to include in the record the balance of the documents identified by Nevada.



4. The parties have agreed that Petitioners may prepare and file with the Court a supplemental appendix containing, to the extent relied upon in the parties' briefs, those documents (identified in Attachment A to this Joint Stipulation) whose inclusion the NRC disputes. The parties have further agreed, in accordance with the procedure adopted by the Court in a similar case, *Nevada v. Department of Energy*, No. 01-1516 (orders of Sept. 6, 2002 and Sept. 20, 2002), that it is appropriate for the Court to defer consideration of whether these documents should be included in the administrative record pending oral argument in this action.
