This letter confirms the telephone conversation between Mr. B. Hamilton of your staff and myself on December 10, 2002, concerning rescheduling the December 16, 2002, management meeting to discuss Oconee's: (1) recent management changes; (2) design basis review initiatives; and (3) future steam generator and reactor vessel head replacements. The meeting will now be conducted on January 28, 2003, from 10:30 a.m. to 12:30 p.m., at the Region II Office, Sam Nunn Federal Center, 61 Forsyth Street SW, Atlanta, Georgia 30303, in Suite 24T20.

This meeting is an open meeting as per "Staff Meetings Open to the Public; Final Policy Statement" (September 20, 2000; 65 FR 56964). This meeting is designated as a Category 1 meeting in accordance with Commission Policy. As such, meetings in this category are typically held with one licensee to discuss particular regulatory issues regarding their specific facility. At this type of meeting, the NRC anticipates that the public would obtain factual information to assist in their understanding of the applicable regulatory issues and NRC actions.
