


The purpose of this modification is to reduce the ceiling to the current obligated amount. Also, the statement of work is revised as shown below. Accordingly, the following changes are made:

1. Section B.3, "Consideration and Obligation - Cost Plus Fixed Fee", subparagraph "a" is revised to read as follows:

" (a) The total estimated cost to the Government for full performance of this contract is \$345,596. Of this amount, \$319,996 represents the estimated cost and \$25,600 represents the fixed fee."

2. Section C, "Description/Specifications/Statement of Work", is revised as specified in CNWRA 9/13/02 letter from W. Patrick, CNWRA, to B. Meehan, NRC.
