


This Modification No. 12 accomplishes the following:

1. Provides a unit price for line item 3.a "Root Cause/Incident Investigation Workshop Presentations" course for Region IV, Arlington, TX, during FY 2003.
2. Provides costs for additional students and a second instructor under line item 3.a "Root Cause/Incident Investigation Workshop Presentations" courses for Headquarters, Regions 1-4, and NRC TTC, during FY 2003.

Accordingly, the following Section(s) of the contract are hereby modified:

1. Section B.8 SUPPLIES OF SERVICES AND PRICES/COSTS, item 3.a, is revised to provide a unit cost for Region IV, and costs for additional students and a second instructor, as described above, for FY-2003. Accordingly, Section B.8 is revised to read as follows:

If class size is between 16 and 25 participants, there shall be an additional charge of \$2,040 for a second instructor.
