Re: Static Eliminator

This letter is to advise your agency that we are unable to locate a Nuclecel static eliminator. The Gilman Brothers Company has leased a P2021-8101 model with S/N A2AW362 under purchase order 02230401. The unit was manufactured by NRD, Inc.

The unit was last used in production operations during the week of August 12, 2002. Extensive efforts to locate this device have been used. Discussions with all employees working in the area, including maintenance and supervisory personnel have been conducted. Additional housekeeping and searching assignments have also been performed.

In an effort to prevent future losses, we have informed employees about the unit. The purpose of the active materials used in construction of the units as well as the importance of control and traceability was explained.

We will continue to search for the missing item and if we are able to locate it in the future, we will advise you.
