SUBJECT: AP1000 - REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC
DISCLOSURE (AW-02-1585, AW-02-1586, AND AW-02-1587)

Dear Mr. Corletti:

By three letters dated December 2, 2002, you submitted three affidavits dated December 2, 2002, executed by Mr. James W. Winters, and requested that the following documents be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.790: WCAP-15949-P, "AP1000 Reactor Internals Flow-Induced Vibration Assessment Program," Revision 0 (AW-02-1586), WCAP-15965-P, "AP1000 Subcompartment Models," Revision 0 (AW-02-1587), and WCAP-15994-P, "Structural Analysis Summary for the AP1000 Reactor Coolant Pump High Inertia Flywheel," Revision 0 (AW-02-1585).

Nonproprietary copies of these documents have been placed in the Nuclear Regulatory Commission (NRC) public document room and added to the Agencywide Documents Access and Management Systems Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (1) the information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without a license from Westinghouse constitutes a competitive advantage over other companies (AW-02-1585 and AW-02-1587),
- (2) the information consists of supporting data, including test data, relative to a process (or component, structure, tool, method, etc.), the application of which data secures a competitive economic advantage, e.g., by optimization or improved marketability (AW-02-1586), and
- (3) use of the information by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product (AW-02-1585, AW-02-1586 and AW-02-1567).

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.790 and on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the versions of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.790(b)(5) and
