Part of the delay in procuring material has been the need to change storage location and the change of personnel. World events have caused proposed projects to be extended to future dates.

The responsibility of Balestracci Unlimited (Garry Balestracci) is to function as the Radiation Safety Officer and provide training and radiation safety consultation as required.



3. A copy of the license application signed by Dr. Crihan will be forwarded under separate cover.
4. Radioactive Material Storage will be at the Quality Services Laboratories, Inc Facility. QSL will have no involvement in the physical use of the licensed material. The agreement involves only storage of licensed material at that facility.
5. Again same as Number 4. I apologize for the confusion. There is no intention or agreement to use the Trainer, Pennsylvania Facility for other than storage of licensed material.
 - a. At such time as Megarad, Inc possess radioactive material under this license, the storage are will be subdivided to segregate Megarad material from QSL material. Currently Megarad does not posses any licensed material.
 - b. A nameplate will be affixed to the exposure device, source changer or shipping container indicating that the material is under the specific control and authorization of Megarad, Inc.
 - c. The Radiation Safety Officer or a qualified properly trained Megarad, Inc radiographer will be responsible for the shipment and receipt of Megarad licensed materials. The material will be physically accompanied during any movement (transport) that occurs either from or to the segregated storage area.
 - d. Each licensee will have separate responsibility to perform any and all surveys of the respective storage areas necessary to ensure compliance with applicable regulations.
