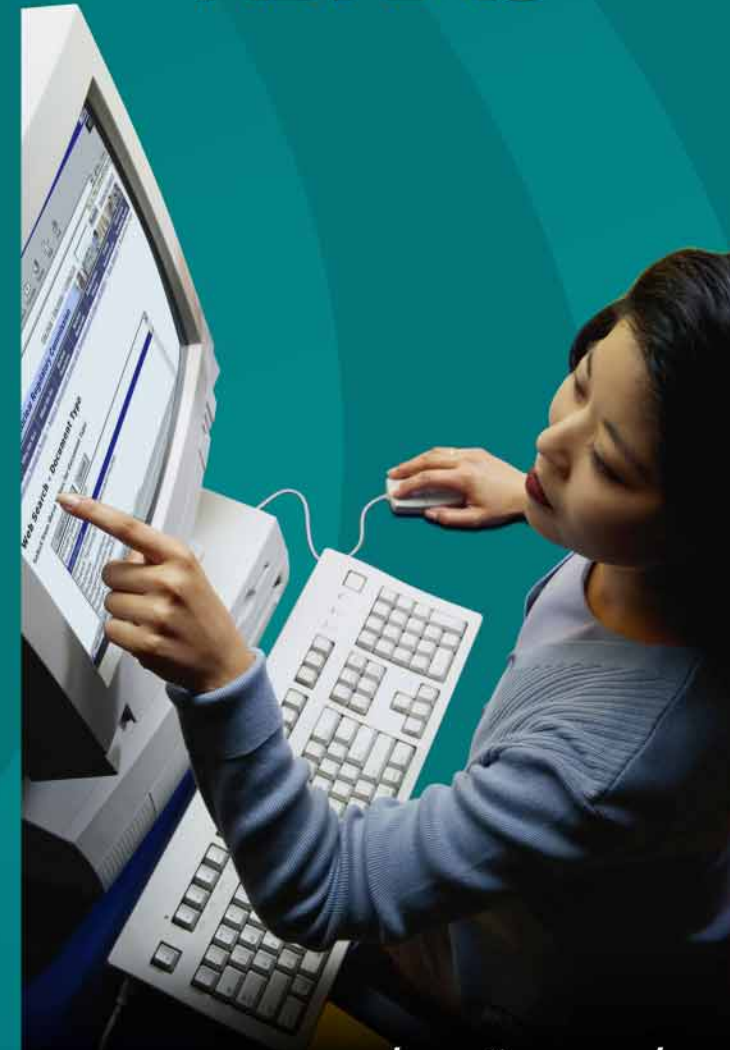

Web-Based Public Access to ADAMS

ADAMS stands for the **A**gencywide **D**ocuments **A**ccess and **M**anagement **S**ystem. It is through ADAMS that the public obtains access to current, publicly available NRC documents. The Nuclear Regulatory Commission has developed a Web-based search interface that allows access to ADAMS. Documents are now available at the NRC Web site using this new search interface through a link on the Electronic Reading Room page.

Overview

Users will find a number of advantages to the Web-based access version of ADAMS:

- No need to download the CITRIX client software
- No internal firewall constraints
- Choice of Basic or Advanced Search Options
- Using a powerful, yet easy-to-use search engine, you will be able to search and retrieve PDF and TIF files of publicly-available documents.



Ordering NRC Documents for a Fee

Documents can be ordered via email to: pdr@nrc.gov or fax your order to: 301-415-3548

Several search options are available:

- **Concept Searching**
Finds entered and related words of documents using natural language queries
- **Pattern Searching**
Also called “Fuzzy” searching; use for misspellings, variant spellings and product names in the text
- **Boolean Searching**
Uses “and,” “or,” “within,” “adjacent” and “between” in search statements; good for compound queries and exact searching

Special Features

The ADAMS user will also find these features available on the Web-based version:

- “More Like” Search: Find a particularly relevant document? Then the “More Like” search button lets you search for similar documents
- The “Already Seen” indicator that notes documents already viewed in search lists
- “Ask Why” which shows the ADAMS user what synonyms were used to retrieve the hit
- “Results List” field selection which can change the display of your results list
- Relevancy ranking of documents locates best documents in a search
- Search terms are highlighted showing key words or phrases

Access to Web-Based ADAMS

Access to ADAMS is easy:

- Using your Internet service provider and Internet Explorer or Netscape, go to the NRC Home Page: www.nrc.gov
- Select the tab fold for Electronic Reading Room
- Select the ADAMS Documents Page
- Select the Web-based public access to ADAMS

Compile document lists by utilizing the Edit/Copy feature in your browser, then copy and paste to your word processor and save.

You can:

- Download and save files
- Print documents
