DEFICIENCY IDENTIFICATION AND REFERRAL

Description of Deficiency:

During audit BQAP-BSC-03-02 of Unsaturated Zone Analysis and Model Reports, a discrepancy was identified in the Verification of Experience for one individual. The Position Description required 4 years of quality assurance experience. The verification of experience form did not identify the 4 years of quality assurance (QA) experience as a requirement through an oversight of the individual preparing the Verification of Experience form. The form indicated no experience requirement. Also, at the time of the original verification of experience, the verifier determined that a portion of the work history for the individual was not able to be verified since the company had declared bankruptcy and had dissolved. At that time the Manager had noted the QA experience of the individual in general terms; however, he had not specifically identified that the Position Description requirement for 4 years of QA experience had or had not been met. During the audit, a Justification Statement (equivalent to Form AP-2.2Q.1) was completed in accordance with the requirements of section 5.4.1(b) of AP-2.2Q, Revision 1, ICN 0 explaining the circumstances, the inability to verify the 4 years of QA experience, and the acceptability of the individual for the position without the verification of that experience.
