37 Brown, Williams, Moorhead & Quinn, Inc. (the "Firm") submits its Cover Sheet  
38 Application (the "Application") for Allowance and Payment of Interim Compensation and  
39 Reimbursement of Expenses for the Period November 1, 2002 to November 30, 2002 (the  
40 "Application Period"). In support of the Application, the Firm respectfully represents as follows:

- 41 1. The Firm is consultant to Pacific Gas and Electric Company, debtor and

debtor-in-possession in the above-referenced bankruptcy case (the "Debtor") or the Official Committee of Unsecured Creditors. The Firm hereby applies to the Court for allowance and payment of interim compensation for services rendered and reimbursement of expenses incurred during the Application Period.

2. The Firm billed a total of \$20,000.47 in fees and expenses during the Application Period. The Total fees represent 84.0 hours expended during the Application Period. These fees and expenses break down as follows:

3. Accordingly, the Firm seeks allowance of interim compensation in the total amount of \$17,007.97 at this time. This total is comprised as follows: \$16,957.50 (90% (85% after July 31) of the fees for services rendered)<sup>1</sup> plus \$50.47 (100% of the expenses incurred).

4           6. With regard to the copies of this Application served on counsel for the

5 Committee, counsel for the Debtor and the Office of the United States Trustee, attached as Exhibit

6 1 hereto is the name of each professional who performed services in connection with this case

7 during the period covered by this Application and the hourly rate for each such professional; and

8 (b) attached as Exhibit 2 are the detailed time and expense statements for the Application Period

9 that comply with all Northern District of California Bankruptcy Local Rules and Compensation

10 Guidelines and the Guidelines of the Office of the United States Trustee.

11           7. The Firm has served a copy of this Application (without Exhibits) on the

12 Special Notice List in this case.

13           8. Pursuant to this Court's "SECOND AMENDED ORDER ESTABLISHING

14 INTERIM FEE APPLICATION AND EXPENSE REIMBURSEMENT PROCEDURE" which

15 was issued March 18, 2002, the Debtor is authorized to make the payment requested herein

16 without a further hearing or order of this Court unless an objection to this Application is filed with

17 the Court by the Debtor, the Committee or the United States Trustee and served by the fifteenth

18 day of the month following the service of this Application. If such an objection is filed, Debtor is

19 authorized to pay the amounts, if any, not subject to the objection. The Firm is informed and

20 believes that this Cover Sheet Application was mailed by first class mail, postage prepaid, on or

21 about December 16, 2002.

22           9. This interim compensation and reimbursement of expenses sought in this

23 Application is on account and is not final. Upon the conclusion of this case, the Firm will seek

1 fees and reimbursement of the expenses incurred for the totality of the services rendered in the  
2 case. Any interim fees or reimbursement of expenses approved by this Court and received by the  
3 Firm (along with the Firm's retainer) will be credited against such final fees and expenses as may  
4 be allowed by this Court.

5           10. The Firm represents and warrants that its billing practices comply with all  
6 Northern District of California Bankruptcy Local Rules and Compensation Guidelines and the  
7 Guidelines of the Office of the United States Trustee. Neither the Firm nor any members of the  
8 Firm has any agreement or understanding of any kind or nature to divide, pay over or share any  
9 portion of the fees or expenses to be awarded to the Firm with any other person or attorney except  
10 as among the members and associates of the Firm.

11           WHEREFORE, the Firm respectfully requests that the Debtor pay  
12 compensation to the Firm as requested herein pursuant to and in accordance with the terms of the  
13 "ORDER ESTABLISHING INTERIM FEE APPLICATION AND EXPENSE  
14 REIMBURSEMENT PROCEDURE."
