The purpose of the meeting was to discuss the integration of the CEOG and the WOG, and their high priority issues. In addition, the risk-informed anticipated transient without scram (ATWS) model and regulatory interface improvements were discussed

The WOG began the meeting with an overview of the approved *New* WOG organization. The *New* WOG will represent 35 members in 10 countries operating 152 reactors. The WOG presented a redefinition of large break loss-of-coolant accident. The WOG continued with a discussion on high burnup lead test assemblies, a risk-informed ATWS model, along with material and security issues. The staff presented their perspective in each area.

The WOG concluded by reviewing the 14 topical reports being reviewed by the NRC. The staff thanked the WOG for their presentation. Meeting slides are available in ADAMS (Accession No. ML023450620).
