The subject relief requests were submitted by FirstEnergy Nuclear Operating Company (FENOC) in correspondence dated January 11, 2002 (Serial Number 2750), February 26, 2002 (Serial Number 2765), and April 25, 2002 (Serial Numbers 2777, 2783 and 2785), and are related to plans to repair the original reactor pressure vessel head and associated control rod drive mechanism nozzles at the Davis-Besse Nuclear Power Station, Unit No. 1.

By letters dated June 14, 2002 (Serial Numbers 2793 and 2794), FENOC requested that review be suspended because it was planning to replace the reactor pressure vessel head.

By letter dated December 20, 2002 (Serial Number 2825), FENOC expressed confidence that the requested reliefs would not be needed, based on progress with efforts to replace the head, and requested withdrawal of the requests.

The Nuclear Regulatory Commission staff agrees that the relief requests are not needed. Therefore, we have ceased our review and, accordingly, TAC Nos. MB3843 (for RR-A20 through RR-A22), MB4949 (RR-A23), MB4950 (RR-A24) and MB4951 (RR-A25) have been closed.
