

NOTICE OF INTENT AND PETITION OF THE PORT SAN LUIS HARBOR DISTRICT  
TO WITHDRAW FROM PARTICIPATION IN THE PROCEEDINGS AS AN  
INTERESTED GOVERNMENT ENTITY

Port San Luis Harbor District ("District") hereby tenders notice of its intent to withdraw and respectfully requests that the Atomic Safety and Licensing Board ("Board") grant the District's petition to withdraw from participation in these proceedings as an interested government entity pursuant to 10 C.F.R. § 2.715(c).

Pursuant to the Board's rulings in LBP-02-23, 56 NRC \_\_\_ (Dec. 2, 2002) and LBP-02-25, 56 NRC \_\_\_ (Dec. 26, 2002) consideration of the District's proffered issues of concern, as well as those issues of particular concern to the District proffered by other parties to the proceedings, has been precluded. Accordingly, the District, after considering the benefits and costs resulting from further participation, has decided to withdraw from participation in the proceedings as an interested government entity pursuant to 10 C.F.R. § 2.715(c).


