

The purpose of this modification is to:

1. Provide incremental funding in the amount of \$114,020.00 to cover the following three courses to be given during FY 2003: IIT Course (\$66,440.00), Root Cause Course at TTC (\$23,015) and Root Cause Course at Headquarters (\$24,565.00), thereby increasing the amount funded in the contract from \$604,739.00 to \$718,759.00.
2. Correct the cost per additional student beyond 15 participants for line item 3.a "Root Cause/Incident Investigation Workshop Presentations" course, as stated in Modification No. 12; and

Accordingly, the following Section(s) of the contract are hereby modified:

1. Section A.2 - Consideration and Obligation -- Delivery Orders (June 1988), first sentence of Subsection (2), as modified in Modification No. 11, is deleted and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this contract is \$718,759.00."
2. Section B.8 SUPPLIES OF SERVICES AND PRICES/COSTS, item 3.a, second paragraph beginning with "The unit prices shall . . .", as stated in Modification No. 12, is deleted and substituted with the following in lieu thereof:

"The unit prices shall include travel costs per course/per fiscal year. The unit price is for the accommodation of 15 participants per course. The cost per person beyond 15 participants is \$1,188. If class size is between 16 and 25 participants, there shall be an additional charge of \$2,040 for a second instructor. Execution of a unilateral contract modification is required of the Contracting Officer should the number of participants exceed 15."
